**You could be eligible for CalFresh (formerly known as food stamps) if you answer YES to these questions:**

1. Are you a resident of San Joaquin County?  YES
2. Is someone in your household a U.S. Citizen or Legal Permanent Resident of the U.S, refugee or asylum?  YES

**\*Did you know...?**

**You may be eligible for CalFresh even if you have income. Beginning June of 2019 SSI recipients will now be able to apply for CalFresh and will not affect their SSI benefits**

**Required Documents:**

Proof of Citizenship or Immigration Status
Proof of Income (for 30 day period)
Utility Bills: (PG&E, Water, Garbage, Phone)
Social Security Number
Picture I. D (adults) and Birth Certificate (Children)
Rent Receipts or Mortgage payment
